- Amslee® Intermediate Childcare. This level is completed after the Basic program and is
 designed for those seeking part-time positions with families or employers. Intermediate
 Childcare providers may be responsible for afterschool and/or weekend care.
- Amslee® Advanced Childcare. This level is completed after the Intermediate program and designed for those seeking full-time positions with families or employers including year-round or full-time summer positions. Advanced Childcare providers may be responsible for several children throughout the entire work day or week while family members are at their places of employment.

- Amslee® Specialist Childcare. This level is completed after the Advanced program and is designed for those seeking full-time positions with additional responsibilities including family assistance and household management or supervisory roles with employers. Additional responsibilities in a home may include managing a weekly schedule, picking up the dry cleaning, preparing meals, and overnight duties. In an employment setting, additional responsibilities may include supporting education or leading group play activities. Specialist Childcare providers are often committed to childcare as their primary employment and have the maturity to work unsupervised while responsible for several children.
- Amslee® Professional Childcare. This level is completed after the Specialist program and is
 designed for those seeking a career in childcare and are likely to commit their time exclusively
 to a family or may be employed as a supervisor in a child focused business. Professional
 Childcare providers may have limited time off and work holidays as they are the central core
 to managing all schedules, logistics, and needs for the entire family or a team working with
 children.



There is also a sixth option which is a Courses Only. The courses only option is designed for individuals seeking personal development to enhance their existing knowledge of childcare without completing a program. The courses only option does not include the job placement services.

All program requirements, including exams, must be completed within 90 days of the Enrollment Date. The Enrollment Date is the date the Enrollment Agreement is submitted with tuition and fees paid.

Program Considerations

Prospective students should understand their personal and professional goals prior to enrolling in an Amslee program. Amslee courses and programs may help gain access to Nanny and childcare positions at a higher wage than those seeking the same work without training. Sitter and Nanny positions are not regulated by state requirements, so courses, certifications, and diplomas are not required for employment.

Some states require childcare workers at licensed institutions including daycare centers and inhome daycares to complete state regulated and approved training and certification. Amslee programs do not meet these individual state criteria. For employment in licensed childcare centers, review the state laws and requirements to understand the educational and training requirements.

Prior to enrolling, prospective students should assess their current qualifications against the enrollment requirements to determine which Amslee program to pursue. If evaluating programs, special attention should be paid to the categories that have minimum requirements and documentation for references and work experience hours. Equally important, CPR and First Aid certification are required but are not offered by Amslee Institute. Online CPR and First Aid training can be taken with the American Heart Association (Adult, Child and Baby First Aid/CPR/AED Online, \$34).

Prospective students can enroll at any time by completing the online process at Amslee Institute.com.

Enrollment Requirements

To enroll, students must read and acknowledge the Catalog and Policies and Enrollment Agreement. Enrollment requirements for programs include:

- ✓ Must be age 16 or older
- ✓ Be fluent in English
- ✓ Provide government issued identification with birthdate
- ✓ Transcripts of High School diploma, equivalent, or current enrollment
- ✓ Complete Student Information form (Amslee Form 100)



Technology requirements:

- ✓ Access to a computer with minimum screen resolution of 1024x768, internet connection, and web browser (Internet Explorer 8+, Firefox 2+, Safari on Mac 1.2+, or Google Chrome) with Javascript and Cookies enabled
- ✓ Access to a computer with installed software programs including Flash Player 9+, Microsoft Word, and a PDF document reader like Adobe Reader
- ✓ Access to printer and scanner
- ✓ A valid email account

Attendance Requirements

With 12 weeks (90 days) to complete the selected program(s), enrolled students are required to complete a minimum of 10% of their online classes each week. Thus, the minimum time requirements per week are:

Program Requirements

To ensure graduates have the knowledge, skills, and experiences to excel in childcare, Amslee Institute programs are a multistep process that includes enrollment, education transcripts, CPR and First Aid training documentation, references, and work experience. Each program builds on the one before from Amslee® Basic to Amslee® Professional Childcare. Students who have little to no experience can build a foundational skill set and over time advance from Basic through Professional. Alternatively, students with some training and experience can start at their appropriate level if all the program requirements are met. Below are the program requirements for each level. Steps to Complete Program Requirements

- 1. Create an online student account and pay enrollment fee and tuition.
- 2. Read, sign, and upload the Enrollment Agreement and Statement of Understanding.
- 3. Submit required program forms and documents digitally in student account
 - a. Complete and sign Student Information Form (Amslee Form 100)
 - i. Submit copy of government identification
 - ii. Submit high school transcript and/or equivalent or post-secondary education
 - iii. Submit copy of First Aid certification
 - iv. Submit copy of CPR certification
 - v. Optional: submit additional information
 - vi. Optional: Sign media release (Amslee Form 104)
- 4. Submit recommendations/professional references (Amslee Form 102). References should be professional, non-family members, ideally from former or current employers. References may also be authored by teachers, counselors, or other community leaders. Persons serving as a reference will be asked to answer 3 questions and provide ratings for a list of attributes as well as an overall recommendation. Persons serving as a reference must also provide their contact information and be willing to confirm authenticity if contacted by an Amslee Admissions officer.

- 5. Submit documented work experience (Amslee Form 103). Work experience must be paid employment and not unpaid care of siblings and/or other family members. To qualify as childcare work experience, the position must include direct supervisory responsibility to care for at least one child between the ages of 0 and 13 and/or up to age 18 if child(ren) have been diagnosed as having special needs.

For each employment experience, the company or family name, job title, dates of employment, and contact information are required. Persons serving as employers must be willing to confirm authenticity if contacted by an Amslee Admissions officer.

- b. Submit confirmation of employment. Confirmation of the employment can be provided by one of the following means:
 - Copies of pay stubs from employers with a job title, dates, and hours worked.

- 6. Complete online courses. The courses are on-demand and self-paced with all courses due to be completed on or before 90 days past the Enrollment Date. The following are the required hours of coursework for each program:
 - a. Amslee® Basic Childcare 10 hours + job placement (3.5 hours)
 - b. Amslee® Intermediate Childcarec. Amslee® Advanced Childcare30 hours
 - d. Amslee® Specialist Childcaree. Amslee® Professional Childcare40 hours45 hours

No textbooks are required for Amslee courses. All content is available online and each course has a faculty authored study guide available. The courses can be paused as needed for note taking and watched multiple times. Courses are not approved for download as materials and content, including video lessons, study guides, quizzes, and tests are copyrighted for the intended use by registered students.

Each course has five multiple choice guiz questions at the end. The guiz guestions are provided so students can self-assess their proficiency with the course content. Courses are complete with an 80% quiz score. Courses and quizzes can be repeated as many times as needed within the 90-day enrollment period to gain proficiency with the material which will be tested by proficiency exams.





7. Pass proficiency exams. Proficiency exams are designed to confirm understanding of the course content for each program and include Basic, Intermediate, Advanced, Specialist, and Professional exams. Each exam is multiple-choice and is pass or fail. Pass requires a minimum correct score of 40 out of 50 earning at least an 80%. Two attempts are allowed for each exam. If a student fails to pass after 2 attempts, a black out period of 7 days is encouraged so students to study the course materials prior to retesting. After four failed attempts of an exam, the student fails the program. If a student fails the program, they can re-enroll at any time at the full rates and must repeat the program in its entirety.

- 8. For Amslee® Professional Childcare program only. The student project is intended to demonstrate and share expertise with the Amslee community. Students will be assigned an Amslee® faculty member who will approve the topic, review at least one draft of the submission with the student, and approve for completion. The student must:
 - a. Sign a copyright (Amslee Form 500) and Professional Childcare media release (Amslee Form 501)
 - b. Choose only **one** of the following as a student project and complete the project within 90 days of the Student Enrollment Date (Amslee Form 502). The project should take approximately 5 hours to complete.

- i. Compose two (2) articles (essays or video) of 850-1000 words or 15 minutes on topics related to Babysitting, Nannies, or childcare. At the discretion of Amslee Institute, the articles or portions thereof, citing the author, may be published on the Amslee Institute website or YouTube.
- ii. Host a 30-minute online and recorded webinar on a topic related to Babysitting, Nannies, or childcare and author corresponding article. At the discretion of Amslee Institute, the articles or portions thereof, citing the author, may be published on the Amslee Institute website or incorporated into course content.
- iii. Develop a complete online course of at least 30 minutes with 5 proficiency quiz questions on a topic related to Babysitting, Nannies, or childcare. At the discretion of Amslee Institute, this course or portions thereof, citing the author, may be offered to Amslee students.
- iv. Submit a proposal to Amslee faculty advisor on other ways to demonstrate and share expertise with the Amslee community. Approval is at the discretion of the Amslee faculty advisor and requires an equivalent amount of effort to the approved options.
- c. Submit a project timeline. The project timeline will include the due dates for the project outline, project draft, and final project review allowing at least one (1) week for the faculty to review each submission. - 9. Complete a program checklist. The submission of this checklist will communicate to Amslee admissions that the program has been completed and is ready for staff to review all the documents and confirm completion.

Program Completion

Students who complete all requirements for a program will earn an Amslee Institute Program Childcare Diploma/Certification which will be provided to the student via the student account within 30 days. The program completion communication will include:

- ✓ A graduation diploma/certification with the Student's Name, Date, Program Name, and Signed by the President of Amslee® Institute officially recognizing the successful completion of the program.
- ✓ An Amslee recommendation that articulates the program achievements with respect to training, work experience, and references.
- ✓ A transcript with a list of completed courses







Transfer Credits

Amslee Institute courses may not transfer to other college or university programs. Students should contact other College or University to understand their policies for transfer credits. Due to the specialization in the academic programs, Amslee Institute does not accept transfer credits from other institutions.

Course Requirements

Amslee Courses are classified as Health and Safety (HS), Childcare (CC), General Education (GE), Job Placement (JP), and Optional (OP). Amslee Institute uses clock hours defined as a period of sixty minutes with a minimum of fifty minutes of instruction in the presence of an instructor.

Numerically, 100 courses are required for the Basic Childcare, 200 courses are required for Intermediate Childcare, 300 courses are required for Advanced Childcare, 400 courses are required for Specialized Childcare, 500 courses are required for Professional Childcare, and 600 courses are for Job Placement.

Student Records

Students have the right to inspect and review the student's education records maintained by Amslee Institute. Upon request, Amslee Institute will provide a copy of a student's educational record for a processing fee (Amslee Form 105).

Students have the right to request that Amslee Institute correct records which they believe to be inaccurate or misleading. If Amslee decides not to amend the record, the student has the right to a formal hearing. After the hearing, if the school still decides not to amend the record, the student

has the right to place a statement within the record setting forth his or her view about the contested information.

Amslee Institute will not release student records unless provided written permission from the student (Amslee Form 105), as allowed by the Family Educational Rights and Privacy Act (FERPA), or as required by law. Students may withdraw from Amslee Institute at any time using Amslee Form 108. Students who do not complete the program within 90 days of enrollment and do not contact Amslee Institute for an extension will automatically be dismissed from the Institute.

Leave of Absence

A one-time 90-day extension may be granted to students who demonstrate in writing (via email to Admissions@AmsleeInstitute.com) a significant hardship that requires additional time to complete a program. Causes for Dismissal

- Failure to perform at the minimum academic standards including but not limited to attendance, completing the online courses with quizzes, and completing the online proficiency exams

Course Descriptions

CC 101: Understanding Children (1.5 hours by Dr. Lauren Formy-Duval). Children are complex and change as they advance in development. This course is an introduction to childhood stages including newborn, toddler, preschool, and primary years with physical, social, and emotional developmental milestones.

CC 102: Children and the Law (1 hour by Aaron Brandel). Laws differ in each state, but compliance with local child safety provisions is always mandatory. This course will review relevant laws on proper transportation, child abuse, emergency childcare, and more. Legal protections and liabilities for childcare workers will also be discussed.

CC 103: Positive Discipline (1 hour by Dr. Lauren Formy-Duval). Positive discipline is based on mutual respect using firm and kind direction to help children learn to manage their emotions and behaviors. This course will examine different types of discipline and what is appropriate for different behaviors,

CC 201: Newborns and Infants (2 hours by Dr. Tali Berkovitch). A newborn baby is born helpless and needs constant care to survive. This course will review neonatal milestones and special care required including diapering, soothing, and signs of illness. CC 202: Toddlers (1 hour by Shaundra Boyd). The toddler years are a critical time for development. Toddlers are beginning to walk, engaging in receptive and expressive communication, and developing social, emotional, and reasoning skills. This course

CC 203: Preschool (1.5 hours by Jena Paulo). Preschoolers are developing their basic life skills, independence, and knowledge they will need as they enter their

school years. This course will review developmental milestones, physical needs, and how to prepare preschoolers for kindergarten.

CC 204: Primary Years (1 hour by Ken James). As children grow into ages 6-8, they continue to advance physically and develop more cognitively, enabling a greater range of behaviors and emotions. This course will review developmental milestones, physical needs, and sexual development.

CC 205: Children and Literacy (1 hour by Christine Ducz). Literacy is an important skill all children need to be successful in life. This course addresses developing early literacy skills in infants and toddlers while promoting strong reading and writing skills for preschool and kindergarten children.

CC 206: STEM Activities (1 hour by Chelsea Herndon). STEM (Science, Technology, Engineering, and Math) will enable the next generation of innovators learn to solve global challenges. This course, for ages 3-5, will provide tools to help children understand complex systems through age appropriate play.

CC 301: Learning Environments (1 hour by Annemarie Guertin). The learning environment for children in the early years (ages 1-5) plays a critical role in brain development and productivity. This course will focus on curriculum design and implementation conducive to the key components of a successful learning environment.

CC 302: Self-Regulation (1 hour by Dr. Lauren Formy-Duval). Self-regulation refers to a person's ability to manage and control their feelings, thoughts, and behaviors. It is a critical foundation for learning and good decision making. This course explores self-regulation and provides information and tools to help foster and support this development in children.

CC 303: Classroom Management (1 hour by Jessica Lofton). Classroom management is an essential element in working with groups of children. This course will introduce practical tools to understand and use an established process that can be applied to group play dates, birthday party games, and summer camp structured activities.

CC 304: Helping with Homework (0.5 hour by Chelsea Herndon). Homework is designed to help students review key concepts and provide extra time to practice new skills. This course will provide tools to create a positive homework environment, ensure student remain responsible for their homework, and share ways to help the children be successful.

CC 305: Children and Music (1 hour by Dr. Beth Stutzmann). Music helps the body and mind work together and exposing children to music at an early age helps development. This course will introduce music and activities to support children of all ages.

CC 306: Children and Art (1 hour by Andrea Sammons). Arts and crafts help children develop mentally, socially, and emotionally as well as boost self-confidence. This course will focus on how art helps develop critical thinking skills as well as pre-reading and writing skills and practice ways to introduce art into a child care environment.

CC 401: Lesson Planning (1 hour by Serenity Bradley). Lesson planning skills are useful when working with a home school program, at a community activity center, or creating an academic schedule for the summer while children are out of school. This course will provide example weekly schedules for ages 3-10 with tools to lesson plan including how to define learning outcomes, materials needed, activities, and time required.

CC 402: Children at Risk (1 hour by Dr. Alaina Desjardin). Children at risk are less likely to transition into adulthood successfully. This course examines the factors that create or increase risk and

provide insights to aid those at risk in the youth population.

CC 403Special Education (2 hours by Kerri Beisner). Special education and skills are needed to care for children with special needs or those with disabilities. This course is designed to introduce childcare providers to different types of special needs, tools that can be used with children, and how to be an advocate for young children with special needs and their families.

CC 501: Theories of Child Development (1 hour by Dr. Alaina Desjardin). Our understanding of human nature and child development is continually advancing. This course reviews human development theories from cognitive, psychosocial, psychoanalytical, and behavioral points of view.

CC 502: Trends in Childcare (1 hour by Kathryn Gonsalves). Childcare approaches and learnings advance with new information and cultural influences. This course has a range of topics including the increase of home schooling, vacation resort and cruise ship childcare, and interest driven learning.

CC 503: Advanced Children (0.5 hour by Dr. Alaina Desjardin). Advanced students, about 3-5% of the school population, exhibit high performance capabilities in intellectual, creative, musical and/or artistic areas. This course reviews myths and misconceptions and shares the six areas a child may be gifted and how to provide them with individualized support.

CC 504: Brain Development. (1 hour by Elena Borrelli). Human brains are built as an ongoing process from before birth and continues into adulthood. This course will introduce brain architecture and how it's the foundation of learning, behavior, and health.

HS 101: Emergency Planning (1 hour by Elizabeth Malson). Being prepared can help identify potential emergencies and possibly save lives. This course will teach specific

actions needed for a wide range of emergencies and provide tools to develop and use an emergency plan.

HS 102: Safety in the Home (1 hour by Marlene Malson). One of the primary responsibilities of a childcare provider is to supervise and monitor the safety of children in their care. This course will identify many of the physical risks a child might encounter in the home environment and discuss ways to eliminate or minimize the risk of harm.

HS 103: Water Awareness (1 hour by Elizabeth Malson). Swimming, boating, and other water sports are popular activities, especially during the summer. This course will provide water safety guidelines when in, on, or around the water.

HS 104: Food Safety (1 hour by Dr. Jennifer Rodriquez-Bosque). From processes on the farm to practices in the kitchen, food safety is important to decrease the risk of foodborne illness. This course will provide some basic concepts of food safety practices for preparing, serving, reheating, and managing food.

HS 201: Fitness Basics (1 hour by Allison Markham). Exercise is a critical component for good overall health to build muscle strength, promote healthy bone growth, and manage weight. This course will discuss endurance fitness, flexibility, strength training, and provide examples of age appropriate exercise programs that improve the overall health and wellbeing of children.

HS 202: Health Basics (1.5 hour by Dr. Alexandra Murr). Everyone feels better and are happier when they are healthy. This course reviews the basics of keeping children healthy and how to manage common ailments and over the counter medications.

HS 301: Fitness for Child Athletes (1 hour by Darrin Prince). Developing fitness in children is vital to preparing them for a smooth transition into individual or team sports. This

course will share the benefits of individual and team sports, the appropriate ages to compete in different sports, teaching sportsmanship, how to help keep athletes safe, hydration, and nutrition for athletes.

HS 302: Nutrition Basics (1.5 hour by Lynn Zepp). Food plays a significant role in our health and wellbeing but not everyone understands the components or how they interact in our bodies. This course will teach the basic components of nutrition, from digestion and absorption, to how nutrition affects health.

HS 401: Nutrition and Health (1 hour by Dr. Alexandra Murr). We find ourselves facing epidemics of obesity, diabetes, and other diet-related diseases and urgently need to promote and engage in healthy eating and lifestyles. This course will discuss the principles of weight management and dietary choices including the height and weight norms for children.

HS 402: Special Diets (1 hour by Allison Markham). Special diets can be driven by medical need or cultural preferences. This course will review common types of diets as well as and their impact on the body with information about vegetarian, paleo, Glutenfree, vegan, Atkins, raw food, and other nutrition options.

GE 101: Professionalism (1 hour by Karli Ortmann). Conducting yourself with high character, integrity, and behaving with moral principles is required to be a positive role model for children. This course will discuss how to engage proactively and help make appropriate choices while employed in childcare.

GE 102: Stress Management (1 hour by Dr. Lauren Formy-Duval). Stress during childcare is inevitable as juggling children, parents, play dates, and a personal life is a lot to manage. This course will discuss how to recognize the different components of stress, both physiological and psychological, and will cover behaviors and techniques

helpful to reduce and manage stress reactions as a caregiver and to help children manage their stress.

GE 301: Communicating with Families (1 hour by Dr. Michelle Dragalin). Communication is the exchange of information and news including our daily conversations. This course will focus on communication skills that strengthen working relationships with families.

GE 302: Types of Families (1 hour by Denise Richardson). Children learn from the families, teachers, and caregivers in their lives with families comprised of traditional and often non-traditional structures. This course discusses the diverse types of families, how to avoid stereotypes, and the importance of developing partnerships with everyone for the betterment of the children.

GE 401: Etiquette and Manners (1 hour by Kathryn Gonsalves). An understanding of etiquette is important for professionalism and teaching children correct manners. This course will provide business etiquette, dining protocols, and social norms for a variety of situations.

GE 402: Household Management (1 hour by Elizabeth Malson). Childcare positions often come with some household management responsibilities including housework, cleaning, or comprehensive household management. This course will share the benefits of schedules and example routines as well as basics on cleaning, laundry, and sewing.

GE 403. Caring for Pets (1 hour by Dr. Patricia Ziefle). In the United States, 68% of families have a pet and household management responsibilities may include caring for a dog or cat. This course teaches how to care for these and other common pets, so you can confidently care for these animals.

GE 404: Global Celebrations (1 hour by Chelsea Herndon). Understanding the

positive attributes of diverse cultures helps children learn more about the world. This course introduces popular days of celebrations from different countries around the world, providing child friendly activities or lessons that help teach diversity.

GE 501: Financial Management (1.5 hour by Marlene Malson). Finances can be stressful and overwhelming. This course will teach the basics on how to track money spent, create a budget, understand taxes, and develop a savings plan.

PS 601: Resume Writing (1 hour by Gregory Cassiere). Resumes are usually the first interaction with potential employers and can be a critical part of the employment process. This course will transform your resume into a powerful tool to market your value to employment or nanny agencies, childcare centers, and families.

PS 602: Job Search Strategies (0.5 hour by Sarah Olson). Knowing the most current job seeking trends and skills creates an advantage in gaining a desired position. This course will review the types of jobs in childcare, practical tools to find the right job opportunities, and how to network and use social media to enhance your professional reputation.

PS 603: Interview Skills (1 hour by Gregory Cassiere). Interviews are a critical part of the employment process that enables potential employers and candidates to learn about each other. This course will help you prepare for an interview, know what to expect during the interview, how to end an interview, and what to write in thank you notes.

PS 604: Negotiating Compensation (0.5 hour by Sarah Olson). Negotiating employment compensation may create anxiety but is an important skill to make sure you feel valued and fairly compensated for your work. This course will help you determine what components of compensation are most important to you and how to effectively

communicate with a potential employer on salary and benefits.

PS 605: Work Agreements (0.5 hour by Elizabeth Malson). Taking the time to think through and write down job expectations will help ensure everyone understands the responsibilities and compensation. Work agreements help reduce confusion and creates a more positive experience. This course will introduce work agreement templates and tools to discuss a work schedule as well as pay, overtime, and other benefits.

OP 101: Tips for Live-In Nanny Positions (0.5 hour by Karli Ortmann). Living with a family while employed as a Nanny has unique benefits and challenges. This course will discuss how manage a position that is often viewed as both family member and employee.

OP 102: Photographing Children (0.5 hour by Marlene Malson). There may be many times when you want to capture a precious moment for the parents of children under your care. This course will help you understand the issues associated with photographing children under your care and provide tips on capturing better images.
